No. 7052-SS-II-II-5/2000-F- The Government of Orissa is pleased to make the following rules to provide incentives for promotion of Small Savings and the same is hereby published for general information, namely-

 (I) These rules may be called the Orissa Small Savings (Incentive Scheme) Rules 2000.

(2) They shall come into force on the date of their publication in the Orissa Gazette.

- 2. In these rules unless the context otherwise requires,
 - (a) "Authorised Government Officials" means District Small Savings Officer, Small Savings Officer and Social Education Organiser/Lady Social Organiser of the Government.
- (b) "Department" means the Finance Department of the Government.
 - (c) "Form" means a form appended to these rules;
 - (d) "Government" means the Government of Orissa;
 - (e) "Post Office" means any Post Office on Orissa doing the Savings Bank work; and
 - (f) "Small Savings" means investment through Kissan Vikas Patra, National Savings Certificate (VIII Issue), Post Office (Monthly Income) Account and any other schemes declared by the Government from time to time.

3. (1) In order to attract deposit from the public under different Small Savings Schemes operated only through Post Offices of Orissa free coupon shall be issued to the investors who have invested the necessary amount as determined by the Government from time to time, in the Small Savings, for participation in a draw for getting cash prizes as incentive.

(2) The investor shall produce the authentic instrument of the Small

Savings for verification by the authorised Government Officials for issue of free coupons after verification of the name and address of the investor, name of the Small Savings Scheme, number and date of purchase of the Small Savings, amount of deposit and the name of the issuing Post Office. 4. The Orissa Small Savings Incentive Scheme shall be run by the Department and shall be administered by the Director of Small Savings subject to the control of the Government.

5. (1) The free coupons for the said Small Savings Incentive Schemes shall be printed in Government Press as a check against unauthorised printing. The facsimile signature of the Director, Small Savings or Deputy Director, Small Savings shall be impressed on the coupons.

(2) Free coupons for Small Savings Incentive Scheme shall be issued to the investors in district and separate series and each such series shall be distinguished by district alphabetical notation such as A, B, C,D and the like .(3) In such series, the coupons shall be serially consecutively numbered from 0000001.

(4) The Government shall determine the number of coupons required to be printed in each series.

6. (1) The number and amount of prizes for each draw shall be determined by the Government and indicated on the reverse of each coupon.

(2) All prizes are guaranteed by the Government.

(3) No coupon shall be eligible for more than one prize in a draw. In the even of more than one prize drawn against a particular coupon, the coupon holder shall be entitled only to the highest prize drawn his/her coupon and there shall be a fresh draw for the other coupon or coupons.

(4) The Government, from time to time shall decide the eligibility criteria for drawal of prize.

7. (1) The period of a particular series and date of draw for that series will be decided by the Government and will be indicated on the coupon itself.

(2) The Government shall have the right to postpone the date of the draw for valid reasons after due publicity of such postponement indicating the revised date of the draw.

(3) The drawal of prize shall be made by use of machines (drums) specially designed for the purpose.

(4) The time and place of the draw shall be given wide publicity

(5) The draw shall be held in a public place under the supervision of committee of judges consisting of not less than their members specially nominated for the purpose.

(6) Two Judges shall form the quorum at the time of draw..

(7) A list duly authenticated indicating the notations of the series released and a list of numbers issued in the series shall be made available to the committee by the Director, Small Savings.

(8) There shall be six machines (drums) located in a conspicuous place by the side of the Committee and each shall bear the following identification marks:-

(9) The Committee of Judges shall decide about the number of discs bearing the number to be placed in machines (drum) No. I. The next five machines (drum) will contain ten discs bearing digits 0 to 9. The discs numbering 6 and 9 shall have further identification label in words six and nine in order to avoid confusion. Each disc shall be encased in a plastic pouch, so that the number of disc cannot be seen. All the plastic pouches shall be identical. The Judges shall satisfy themselves that all discs enclosed in plastic pouches are put in the machines (drums) before the draw. The draw shall commence with the ringing of a bell by one of Judges and all the drums will be rotated for about one minute so that the plastic pouches containing the discs get well shuttled and after one minute the machines (drums) shall be halted in ringing of another bell. On the halting of the machines (drums) one pouch from the 1st drum shall be picked up by a person called for the purpose by the committee. The pouch shall be taken to the nearest Judge sitting on the pendal who will open it and announced the digit in the disc and this will also be announced over the mike. This number shall be simultaneously put in the Notice Board. This process shall continue for all the six drums serially in ascending order and digits taken from each machines (drums) shall be noted on the Notice Board from left to right.

(10) In respect of prizes exceeding Rs.2,000 (Two thousand) the prize winning numbers shall be drawn in full for all the six digits.

(11) In respect of prizes of Rs.2,000 (Two thousand) and below the prize winning number shall not be drawn in full but in combination of last two, three or four digits as the case may be for every block of coupon under each category of prizes. The quantum of such block shall be determined by the Committee of the Judges keeping in view the number

of prizes in each category and the total number of coupons issued for the draw. All coupons in each block, whose numbers and with the combinations drawn for one category of prize shall be eligible for that prize. (12) In case, the full prize winning number for a particular category of prizes becomes same as that drawn earlier, it shall be treated as cancelled and a fresh draw shall be tried. This process shall continue till the number drawn is different. Further, if combination of digits drawn, do not correspond to the number of any coupon issued to the investors, the same shall not be eligible for any prize. However, in case, a full number drawn, does not correspond to any coupon issued shall be cancelled and a fresh draw shall be made.

(13) The prize winning number shall be entered by each judge of the committee of judges present at the time of the draw in the blank result sheets supplied for the purpose. Simultaneously, the numbers shall be announced over the mike and shall be indicated on the Notice Board. The result sheets so entered by the judges shall be handed over after duly signed and shall form the basis for recording the results in the register of prize winning numbers.

- 8. The list shall be published in the official Gazette and such publication shall constitute the official announcement of the results for the purpose of draw. Wide publicity shall also be given through local dailies containing the list of prize winning numbers.
- 9. (1) Every prize amount shall be claimed by submitting a claim bill in the form annexed to this rule. The winners of the prizes amounting to Rs.50,000 (Fifty thousand) and above shall claim the prize amount from the Directorate of Small Savings at State Headquarters. Other prize winners shall claim the prize amount before the Collector of the concerned revenue district having one revenue subdivision and before the concerned Sub-Collector in case of revenue district having more than one Sub-Division.

(2) A copy of the Form shall also be published in the Local Daily Newspapers along with the list of prize winning coupon numbers. The prize winners shall claim the prize amount in the claim bill in the Form and send the claim bill along with the original copy of the prize winning coupon and Xerox copy of the concerned Small Savings instruments by registered post with in the stipulated period to the concerned Collector or Sub-Collector, as the case may be for sanction of the prize amount. On receipt of the intimation from the Collector or Sub-Collector, the prize winner shall collect the prize money in person from the office of the Collector or Sub-Collector. The original Small Savings instrument shall be produced for verification at the time of payment. A coupon which is torn or mutilated beyond recognition shall not be considered as valid coupon for any prize. (3) All prize winners shall claim the prize amount within 90 days from the date of draw. No claim for a prize shall be entertained after expiry of the said period: Prize amounts not claimed within the said period and the claims rejected by the Director of Small Savings, shall lapse and amounts shall be forfeited.

- 10. It shall be lawful for the Government to delegate the powers vested in any authority under these rules to such officer for such purpose and subject to such condition as it may specify by order in writing.
- 11. All correspondences regarding any subject matter covered under those rules shall be made either in English or in Oriya.
- 12. The expenditure on payment of prize money shall be debit able to "Demand No. 05-2047-Other Fiscal Services-103-Promotion of Small Savings-0005860-Headquaters-2000000-other charges" and "Demand No. 05-2047-Other Fiscal Services-103-Promotion of Small Savings-0002920-District Establishment-2000000-Other Charges.
- 13. The Small Savings Incentive Coupon Books containing both used and un-used coupon excluding those books containing prize winning coupons of a particular series shall be preserved for six months from the date of draw of that series and the Small Savings Incentive Coupon Books containing the prize winning coupons of a particular series will be preserved for one year from the date of the draw of that series.
- 14. If any question arises as to the interpretation of these rules or any other matter not expressly provided for in these rules, the matter shall be referred to the Government for a decision and the decision of the Government shall be final.
- 15. The Orissa Small Savings State Lottery Rules, 1993 published in the extraordinary issue No. 404 of the Orissa Gazette dated the 12th March, 1993 under the notification of the Government of Orissa No. 11269-SS-II-II-1/92 (Pt.) F., dated the 10th March, 1993 are hereby repealed.

- 3. In Rule 5 (2) after the word "notation such as" following words shall be inserted. "AA, AB, AC, AD & the like" and the words "A, B, C, D and the like" shall be omitted.
- 4. (i) In Rule-7(5) after the word "consisting" following are to be included.

"Three Judges nominated specially by Government from the field of Administration, Judiciary & Education." And following existing words "of not less than three members specifically nominated for the purpose" shall be omitted.

(ii) In Rule 7 (6) in place of "Two Judges" "Two nominated Judges" shall be provided.

- (iii) In Rule 7 (10) in place of the word and figure "Rs.2000/- (Two Thousand)" the word and figure "or Rs.5000/- (Five Thousand)" shall be inserted.
- (iv) In Rule 7 (11) for the word and figure "Rs.2000/- (Two Thousand) and below" the words and figure "or Rs.5000/- (Five Thousand) and below" shall be inserted.
- 5. (a) In Rule 9 in the "Form of claim bill", after the column, i) following two columns shall be added.

(b) In Rule ((2) in place of third and fourth sentences the following shall be inserted.

"On receipt of the intimation from the Office of the Collector or Sub-Collector, as the case may be the prize winner shall produce original Small Savings instrument for verification before them. After verification of the genuineness of the claims, prize amount shall be sanctioned and credited to their S/B Account."

The Government of Odisha is pleased to make the following amendments to the Odisha Small Savings (Incentive Scheme) Rule, 2000.

- 1. (i) These rules may be called the Odisha Small Savings (Incentive Scheme) Amendment Rule – 2015.
 - (ii) They shall come in to force on the date of their Publication in the Odisha Gazette.
- In Rule 2 (e) after the word "and" the following words shall be added.
 "Bank means any Commercial Bank authorised to deal with Small Savings Deposits in Odisha."
- In Rule 3 (1) after the words "through Post Offices" and before the words "of Odisha" the following words shall be inserted.
 "and Commercial Banks"
- 4. In Rule 3 (2) in the end of the last sentence the following words will be added "or authorised Commercial Bank as the case may be"
- 5. In Rule 5 (1) words "be printed in Government Press as a check against unauthorised printing. The facsimile signature of the Director, Small Savings or Deputy Director, Small Savings shall be impressed on the coupons" shall be substituted by the words
 "be issued to investors being generated by Web application which will bear the facsimile signature of the Director Small Savings or Deputy Director, Small Savings for authentication"
- 6. Rule 5 (4) shall be omitted
- 7. In Rule 6 (1) the word "reverse" would be replaced by the word "body"
- 8. In Rule 6 (3) The word "number" will be added after the word "coupon" appearing in all places. The words "or coupons" appearing at the end of the sentence shall be omitted.
- 9. In Rule 7 (11) after the word "last" and before the word "two" the word "one" shall be inserted.

After the end of the sentence the following sentence shall be added.

"In case of drawal of such prizes in quantum, total number of prizes may be reduced due to cancelation, invalid or any other reason which may be inevitable during issue of coupons and fixation of quantum"

- 10. In Rule 9 (1) the words appearing after district "having one revenue subdivision and before the concerned Sub-Collector in case of a revenue district having more than one subdivision" shall be substituted by the words "where the coupon has been obtained"
- 11. In Rule 9 (2) the words "or Sub-Collector, as the case may be" appearing in the 2nd sentence shall be omitted.

The following sentence shall be added after the second sentence.

"In the event when prizes are won by separate coupon numbers belonging to a common coupon sheet, the prize winner will enclose the original coupon against his claim application for prize of higher or equal amount and a xerox copy for the other winning coupon number, duly authenticated by the concerned District Small Savings Officer".

The following five sentences will be inserted after the sentence ending with word "SB Account" and before the beginning of the last sentence.

"Similarly, the prize winners of the prizes amounting Rs.50,000 and above shall submit the claim bill in the claim form along with original winning coupon and original copy of the Small Savings instruments before the District Small Savings Officer concerned within 90 days from the date of draw or within the period as decided by the Government for verification. After Verification the District Small Savings Officer concerned will submit the proposal enclosing original winning coupon and Xerox copy of the Small Savings Instrument to Directorate, Small Savings at State H.Qrs. for necessary sanction and payment. This amount will be paid to the winner in shape of Bank Draft or by crediting to their Bank Account.

Income tax deduction wherever applicable will be made at the time of disbursement of any prizes."

- 12. In Rule 9 (3) at the end of the first sentence the following words will be inserted "or within the period as decided by the Government"
- 13. In Rule 13 Rule will be substituted by

Data on Web Generation of coupons available in Website of N.I.C., Odisha State Centre, Bhubaneswar will be preserved for 3 complete years and the backup data will be provided periodically to Finance Department for preservation.

All office copies of the Small Savings Incentive Scheme Coupons of all Issuing Officers of the District will be preserved in the office of the District Small Savings Officer for 3 years for verification and payment of claims of the prize winners.
